To be considered for an award, you must meet the following criteria:

* completed 35 hours of pro bono service (i.e., without pay/without course credit) while at law school (at least ten of those hours must be during the third year of law school). Involvement in Pro Bono activities during one summer while at law school can count toward this requirement, with prior approval from the Assistant Dean for Pro Bono and Public Interest Programs.

*provided service through either a law school sponsored project (i.e., Bankruptcy Pro Bono Project, VITA, Voters' Rights Project) or through an external public interest legal organization (i.e., South Jersey Legal Services, Community Legal Services, Inc.). In the case of the latter, the student must have obtained prior authorization from the Assistant Dean for Pro Bono and Public Interest Programs and submit a summary of volunteer activity signed by a supervisor.
